Invitation to Bid for the Supply and Delivery of Equipment, Materials, and Labor for the Construction of Distribution Lines of 2025 Sitio Electrification Program (SEP) Projects covering 15 Sitios in Baao, Bato, Bula, Buhi and Nabua, including the House Wiring Materials and Labor

- 1) The **Camarines Sur III Electric Cooperative, Inc. (CASURECO III)**, through the 2011-2023 *Subsidy Savings*, intends to apply the sum of **Php35,316,776.85 for the Construction of Distribution Lines (Lot I), and Php1,508,245.20 for the Housewiring (Lot II)** being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2) The **CASURECO III** now invites bids for the construction of **26.450 kilometers primary lines and 26.450 kilometers secondary lines, and housewiring connections for 231 household beneficiaries**. Completion of the Works is required **within ninety (90) days**. Bidders should have completed, **within the last two (2) years**, from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3) Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the implementing Rules and Regulation (IRR) of the Republic Act (RA) 12009.
- 4) Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships, corporations or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 5) Interested bidders may obtain further information from the BAC secretariat, *Christine Cruz and James Rick Balanon* and inspect the Bidding Documents at the address given below from 8:30 AM to 4:30 PM.
- 6) A complete set of Bidding Documents may be acquired by interested bidders on July 1, 2026 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand Pesos (Php25,000.00)**.

It may also be downloaded from CASURECO III's website, after payment of the applicable fee for the Bidding Documents.
- 7) The CASURECO III will hold a **Pre-Bid Conference on July 13, 2026 at 1:30 PM at CASURECO III Conference Room** and/or through video conferencing via Zoom Online Platform, which shall be open to prospective bidders.
- 8) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below on or before **July 27, 2026 at 11:59 AM**. Late bids shall not be accepted.
- 9) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 10) **Bid opening shall be on July 27, 2026 at 1:30 PM to be held at CASURECO III Conference Room.**
